**Sub: Disclosure under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('Listing Regulations')**

In furtherance to the disclosure dated August 5, 2024 and pursuant to Regulation 30 of the Listing Regulations, we wish to inform that the Hon'ble Supreme Court, vide order dated December 12, 2024 in proceedings filed by Delhi Metro Rail Corporation ("DMRC"), has issued a notice to Managing Director of Delhi Airport Metro Express Pvt. Ltd. ("DAMEPL"), (Respondent No.2) and Managing Director of Axis Bank (Respondent No.4), to show cause as to why contempt proceedings should not be initiated against them for violation of directions contained in Judgment dated April 10, 2024.

The Company is not a party to the proceedings initiated by DMRC. The Judgment dated April 10, 2024 does not impose any liability upon the Company and the Company has not received any money from DMRC / DAMEPL.

DAMEPL, the SPV shall take appropriate steps to protect its interest in the aforesaid matter. The financial implications are unascertainable at this stage. The copy of the Order dated December 12, 2024 is enclosed.
