## **NOTICE OF POSTAL BALLOT**

Members are hereby informed that pursuant to Sections 108 and 110 and other applicable provisions of the Companies Act, 2013, as amended and the rules and regulations made there under, read with Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014 and Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended, the dispatch of Notice of postal ballot dated Thursday, March 16, 2017 along with the explanatory statement thereto ("Postal Ballot Notice") and postal ballot form to the members of the Company, in respect of the resolution for further issue of capital, has been completed on Saturday, March 25, 2017.

The Postal Ballot Notice along with the postal ballot form was dispatched (i) through e-mail to those members whose e-mail addresses were registered with the Company or Depository Participants with whom such members maintain demat accounts as on Friday, March 17, 2017 ('Cut-Off Date'); (ii) through physical mode along with a postage prepaid self-addressed business reply envelope to all the members at their registered address, for seeking their approval by way of a Special Resolution through postal ballot.

The aforesaid resolution is to be transacted by means of postal ballot including voting by electronic means (e-voting) in terms of Section 110 of the Companies Act, 2013 read with Rule 22 of the Companies (Management and Administration) Rules, 2014, Karvy Computershare Private Limited ("Karvy" or "Registrar") has been engaged by the Board of the Directors of the Company ("Board") for providing the e-voting platform.

Members whose names appear in the register of members of the Company or in the register of beneficial owners maintained by the depositories as on the Cut-Off Date, i.e., Friday, March 17, 2017 will be entitled to cast their votes by way of postal ballot or e-voting. Any person who was not a member of the Company as of the Cut-Off Date should accordingly treat the Postal Ballot Notice as for information purposes only.

Voting through postal ballot and e-voting will commence on Sunday, March 26, 2017 (10.00 A.M.) and will close on Monday, April 24, 2017 (5.00 P.M.). Postal ballot forms received after the 5.00 P.M. on Monday, April 24, 2017 will be considered invalid. E-voting will be disabled by Karvy at 5.00 P.M. on Monday, April 24, 2017.
